RULES APPLICABLE TO MEMBERS

- A. All facilities/equipment must be returned in as good a condition as when received. Cost of any repairs up to _____ will be borne by the Member.
- B. The Member agrees to indemnify and save and hold harmless CCSAI and the City of Clearwater and to accept all liability arising out of, or resulting from any accident, illness, sickness or other injuries, including death, at any time occurring to persons (other than employees of the City or CCSAI, while acting in their capacity as employees) and to property of others during time of rental. The Member agrees further not to incur any debts, which may be required or requested to be borne by CCSAI.
- C. Use of sailing center boats is based solely on availability as determined by CCSC Staff.
- D. Lifejackets must be worn at all times while aboard any CCSC boat, dock, or any other area deemed necessary by CCSC staff. Shoes/protective footwear must be worn at all times while on CCSC property, CCSC boats, or in any CCSC program or activity.
- E. Parking at the center is included as a privilege of membership.
- F. Members will be required to demonstrate proficiency on boats they wish to use.
- G. Minors must be supervised at all times by a responsible adult.
- H. CCSC staff will determine if weather conditions are acceptable for sailing.
- I. CCSC staff will determine appropriate boating boundaries.
- J. No modifications of the CCSC boats will be allowed.
- K. Set up, breakdown and cleaning of the boats is the member's responsibility.
- L. Boats must be in one hour before closing.
- M. This agreement is subject to termination or suspension by CCSAI for failure by the member to comply with these rules, with no refund of membership fees.

Members/Guest Policy:

The following policies are designed to promote the safe and fun use of CCSC facilities and boats by all members and guests. These policies alone do not guarantee your safety. Members/guests are expected to conduct themselves in a safe and prudent manner at all times, whether their specific actions are addressed by policy or not.

PFD/Lifejackets-

An approved PFD's of correct size/weight will be worn and correctly fastened/adjusted any time a member or guests goes beyond the fence going to the beach. This includes any usage of the dock, entry into the water for any reason, and at ALL TIMES while underway on any CCSC boat. Failure to follow this policy will result in loss of privileges with NO reimbursement of any fee/payments.

Consumption of Alcohol

Consumption of alcohol in any form is prohibited while at the CCSC.

Exceptions:

1. In the Carlisle Room and upper balcony, for renters and their guests, during the rental period.
2. During other events that occur after regular center hours, with prior CCSC permission.

Smoking:

Smoking is prohibited in all indoor areas of the CCSC. This includes all office spaces, work rooms, and restrooms. Smoking is also prohibited at all times while aboard any CCSC vessel.

Swimming

Swimming is not allowed from the CCSC property including docks or off of any CCSC vessel.

Shoes

Shoes are required at all times while at the CCSC or aboard any CCSC vessel.

Set Up, Launching& Landings:

Inspect boat for damage: Report to office via damage report form. You will be held liable for any damage that is on your vessel after you use it.

Check drain plugs

Monohulls -no groundings on beach-anchor/moor for launch/ retrieval with a dolly

Catamarans:

Round/stop before beaching

If leaving sail up: Face into wind, remove main sheet
